SUBJECT: Request to Increase Membership of the Intelligence Joint Cross-Service Group

Reference your memorandum dated July 30, 2003 which directed the Intelligence Joint Cross-Service Group (IJCSG) to complete a broad, comprehensive review of Defense intelligence capabilities and capacities. The process for evaluating Department of Defense (DoD) sites for Base Realignment and Closure (BRAC) determinations will involve locations that provide support to both Departmental and National Intelligence Community intelligence activities. In many cases, the significance of National Intelligence Community intelligence activities located at DoD sites is not overtly apparent.

In an effort to accommodate both the BRAC process and National Intelligence Community intelligence activities located at DoD sites, we have been working closely with the Director Central Intelligence and affected elements of the National Intelligence Community. The IJCSG believes that this is best accomplished with the Community Management Staff (CMS) transitioning from its current observer status to IJCSG Principal member.

Accordingly, we request your authorization to designate Mr. Robert Korte, Director of the Program Assessments and Evaluation Office, Community Management Staff as Principal IJCSG Representative. Should you have any questions, please feel free to contact Ms. Deborah Dunie at (703) 614-0578.
