1. I'm writing to express what I feel are reasons why Cannon AFB should not be closed. I am a retired Chief Master Sergeant and have spent 30+ years in the Air Force. I have assigned to 14 bases during my career and spent short periods of time at over 15 other bases performing temporary duty. I think I can speak from experience when I tell you that no Air Force Base I have ever been at has the facilities, training capabilities and community support that I have seen at Cannon AFB.
2. Cannon does not fit the criteria for base closure. The base has an abundance of air space and no encroachment issues. The New Mexico Training Range Initiative, when implemented, will allow pilots to fly supersonic training missions. This coupled with the almost perfect weather we enjoy year round allows our pilots to train for real-life situations.
3. The Melrose bombing range is literally seconds from the end of the runway. This allows pilots to be airborne and begin their training operations without wasting fuel just to get to the range.

4. Cannon has the space and facilities to incorporate joint warfare training under a number of different scenarios. It also has the ability to support future training missions such as the F-22, Joint Strike Fighter and other military aircraft.
5. Eastern New Mexico and West Texas are home to a large military retiree population. These people rely on Cannon for healthcare, shopping facilities, and more. There is no other installation close by to serve the retired military.
6. The local community has had a strong, 50-year relationship with the base. Curry County, in conjunction with the state of New Mexico, purchased air easements around Cannon and GAVE them to the Air Force. The local community purchased land north of Cannon and GAVE it back to the Air Force for additional housing, now known as Chavez Manor. Our community purchased land west of Cannon and GAVE it back to the Air Force for the installation of instrument lighting on the alternate runway at the base. Leaders in our community lead the effort to expand and convert the air space to supersonic capability through the New Mexico Training Range Initiative.
7. From a financial perspective, the closure of Cannon will devastate the local economy. In the mid-90's Cannon was downsized and lost 20%-25% of their population. The effect it had on the local housing market was just short of catastrophic. Many of the military member's houses were purchased by the government under the Homeowners Assistance Program through the Corp of Engineers. In most instances these home were then re-sold for considerably less than market value which in turn brought down the value of other homes in the area. The number of Realtors dropped from nearly 100 to less than 50. Multiply that effect by 4 or 5 times if the base were to close and you can see what a dramatic effect that will have on just the real estate segment of our economy. I can't begin to tell you the residual effect on other commercial and retail businesses. We are by no means a wealthy community and the effects of a closure would be more significant than other communities that do not rely on the military presence for much of their livelihood.
8. This community has supported the base like no other community over the last 50 years. We've done so financially, morally, spiritually, and above all, consistently.

9. You are tasked with an unbelievably difficult assignment and I am trying to provide you with information why Cannon should not be on the list for closure.
