MEMORANDUM FOR MR. FRANK CIRILLO, DIRECTOR, REVIEW AND ANALYSIS,

SUBJECT: OSD-BRAC Clearinghouse Tasker C0825 - FW: JCS Clearinghouse Request #50

1. The Supply and Storage JCSG is pleased to provide the following responses to the questions asked in your 5 Aug 05 memorandum to the BRAC Clearinghouse.

a. Question. Please explain which type of inventories (consumables?) will be consolidated from Corpus Christi Army Depot?

Answer. The recommendation titled "Supply, Storage and Distribution Management Reconfiguration" consolidates supply and storage functions performed within maintenance depots and shipyards under DLA management. All supplies and materiel (to include consumables) used in depot and shipyard maintenance will be consolidated under DLA control.

b. Question. 13 Industrial Activities are collocated with DLA distribution depots and 8 Industrial Activities are not collocated with DLA. What mission will the Industrial Activities have once this recommendation is approved?

Answer. This recommendation has no impact on the missions assigned to maintenance depots and shipyards. At locations where DLA Distribution Depots currently exist, the recommendation simply consolidates under DLA control the internal supply and storage functions currently performed by the services.

c. Question. Please explain how attachment 1 of the memo referenced above relates to the recommendation of Supply, Storage and Distribution Management Reconfiguration.

Answer. The Secretary Wynne memorandum dated 22 Jun 05 and its attachment are directly related to the recommendation titled "Supply, Storage and Distribution Management Reconfiguration." The memorandum directs the transfer of service supply and storage functions, along with space and personnel resources to DLA. The recommendation then consolidates the transferred functions and resources to eliminate redundancies and improve efficiency.

During the scenario development phase of BRAC-05, the Industrial Joint Cross Service Group (IJCSG) and the Supply and Storage Joint Cross Service Group (S&S JCSG) coordinated to develop two scenarios to establish DLA as sole process owner for supply and storage on installations having naval shipyards and depot maintenance activities. The IJCSG

scenario realigned all Air Force, Army, Marine Corps and Navy supply and storage functions at shipyards and depot maintenance activities to DLA, including materiel ordering, processing, issuing and storage of inventory. The IJCSG scenario called for a "no-cost, in-place" transfer of infrastructure and personnel. The S&S JCSG scenario incorporated the IJCSG data and consolidated the transferred functions and resources under DLA control. Both scenarios were presented and approved in a combined presentation to the ISG. The S&S JCSG scenario was later developed as a final recommendation. The IJCSG scenario was not developed as a final recommendation. Counsel advised, since the transfers fell below the BRAC threshold, that OSD could either wait to direct the transfers after the S&S JCSG recommendation received Commission approval, or could affect the transfers now contingent on Commission approval of the S&S recommendation. In the interest of openness and clarity, the later approach was selected.
