Dear General Hill:

On May 31<sup>st</sup> and June 1<sup>st</sup>, Chairman Principi and Commissioners Coyle, Bilbray and Newton traveled to Connecticut to receive an in-depth briefing and tour of the facilities at Navy Submarine Base New London. From what we observed, the visit was very constructive, providing invaluable insight for Commissioners and staff into the base's profound military value.

We therefore wish to extend an invitation to you as well, to see first-hand the extensive capabilities available at this installation. We strongly believe that such a visit is the best way to fully understand the unique synergies that exist among the base's various components and with our nation's premier submarine builder, General Dynamics Electric Boat, located just a very distance from the base.

We understand that you are operating under a very constrained schedule, and have a limited time to visit military facilities throughout the country marked for closure and realignment. However, given the gravity of the Pentagon's decision to close down Navy Submarine Base New London, and the dangerous impact we believe such a closure would have on U.S. national security, we hope that you will consider making the trip to southeastern Connecticut at your earliest convenience.


It is our belief that the Department of Defense and the Navy grossly underestimated this base's military value and vastly overestimated the calculated cost savings that would arise from eliminating and then re-constituting elsewhere, facilities such as the Navy Submarine School, the submarine piers, and the Navy Submarine Support Facility that comprise Navy Submarine Base New London.






