Dear Chairman Principi:

The Board of Commissioners, Greene County, Ohio, wish to add our support for the Development & Fielding Systems Group, commonly referred to as DFSG, from being realigned from Wright-Patterson AFB to Hanscom AFB, Massachusetts.

We want to borrow the facts from a background paper prepared by the Dayton Coalition concerning the background, cost and mission implications of this move.

**Background Paper on DoD Base Realignment and Closure (BRAC)
Recommendation to Realign Information System Positions from Wright-Patterson AFB, OH and Maxwell AFB, AL to Hanscom AFB, MA**

Background

- The organizations at WPAFB (Development & Fielding Systems Group - DFSG) and Maxwell AFB (Operations & Sustainment Systems Group - OSSG) are focused on acquiring and implementing commercial-off-the-shelf (COTS) Enterprise Resource Planning (ERP) applications (e.g. Oracle, SAP etc...) in support of Air Force logistics, supply and financial management functions.
- The organizations at Hanscom AFB conduct information technology research, and develop military unique software applications for **warfighter command and control weapon systems.**
- The DoD BRAC recommendation calls for consolidating the business system acquisition and implementation functions from WPAFB (approximately 2,700 jobs) and Maxwell (approximately 3,000 jobs) with the weapon system information technology research and development functions at Hanscom. The affected job numbers for both WPAFB and Maxwell reflect military, civilian, direct support and development contractors. *Not all of these were accounted for in the cost analysis supporting the DoD recommendation.*

Cost Implications

- Local Dayton contractors working at the base and directly supporting the WPAFB acquisition mission were not factored into the DoD BRAC cost equation.
 - DoD suggests the realignment will save \$229M by 2025.
 - There is additional cost of \$30,000 per support contractor in Boston versus Dayton. This amounts to an additional \$42,360/year costs to support the realignment to Hanscom AFB (1412 contractors at an increased cost of \$30,000 each)
- **Rather than the Defense Department reported savings of \$229 million dollars by 2025, there would be a loss to DoD of \$421 million.** This loss to DoD exceeds \$800 million when the number of *development* contractors is considered - there will never be a savings! Computing the same for Maxwell contractors, further increases the costs.

Mission Implications

- For the next ten years, the WPAFB organization's primary program is the acquisition and implementation of an ERP solution.
 - According to Gartner Research Publications, ERP implementations are risky endeavors. They highlight that one of the key success factors is close interaction between the implementation team and the application users.
 - The application users for the ERP implemented by the WPAFB organization is HQ Air Force Materiel Command, also located at WPAFB.
 - Additionally, there is significant ERP relevant intellectual capital resident in the contractor community in Dayton, many of whom retired from WPAFB.
- Realigning the ERP acquisition and implementation function from WPAFB to Hanscom is not only more costly, it induces significant mission risk to an already risky endeavor.

1-(Department of Labor, Bureau of Labor Statistics - Computer and Mathematical Science Occupations average: Boston MSA average salary (\$76,870); Dayton Springfield MSA average salary (\$61,360) - Escalation Factor for cost of living in Boston is 1.30; Government cost of an contractor in Dayton ~ \$100,000, applying the cost of living index of 130 to \$100,000 equals ~ \$130,000 for the same contractor in Boston).

We believe that it is sound fiscal policy to retain DFSG at Wright Patterson AFB, Ohio, as well as good citizenship. We are a community of patriots, ROTC parents and 4th of July celebrants. We strongly urge you and the fellow BRAC Commissioners to reject the Department of Defense recommendation, regarding the move of DFSG and retain it at Wright Patterson Air Force Base, Ohio.
