Dear General Hill,

Congratulations on your appointment to the Base Realignment and Closure Commission (BRAC). I appreciate your service to our country and realize the enormity of the job you have ahead of you.

I wanted to take a moment to share with you some information about Fairchild Air Force Base, home of the 92nd Air Refueling Wing (ARW). Fairchild, located 10 miles west of Spokane, Washington, is a modern, multi-mission base that is home to one of the world's largest air-refueling wings and four co-located units. These units include Washington National Guard 141st Air Refueling Wing; the Joint Personnel Recovery Agency; the 336th Training Group that operates the Air Force's only survival school; and Air Combat Command 2nd Support Squadron.

The information enclosed outlines the critical role Fairchild AFB is playing in the Global War on Terror. As the only active duty air-refueling wing west of the Rocky Mountains, Fairchild is well positioned for growth and future missions with 4,300 acres of well-managed land that is protected from encroachment and airspace interference.
