Dear Secretary Principi:

On behalf of the more than 600,000 federal employees represented by the American Federation of Government Employees, AFL-CIO (AFGE), including 250,000 civilian employees in the Department of Defense (DoD), I am writing to ask your assistance in securing for me and four other leaders of our union, the opportunity to testify at the June 20 hearing of the Base Closure and Realignment Commission (BRAC) in San Antonio, Texas. I am contacting you directly because our organization's efforts to go through the BRAC Commission's normal procedures for being placed on the witness list have so far not been successful.

AFGE represents approximately 24,000 DoD civilian workers in Texas. We have a direct interest in the Commission's decisions to eliminate or move civilian DoD jobs and functions. Our testimony offers the Commission a unique perspective that will not be represented by other witnesses.
