

The Fire Advisory Board consists of representatives from the Niagara County Fire Chiefs' Association, the Niagara County Volunteer Firemen's' Association, all area deputy coordinators, the Niagara County Legislature and the three cities in Niagara County: Lockport, Niagara Falls, and North Tonawanda,

It is the feeling of the first responders of the County of Niagara that any closure of this base is detrimental to the public safety of not only the Niagara County citizens, but the entire United States. The services that the members of this base have played in the recent war in Iraq speak for themselves.
