However, in the last few days I have been dismayed and outraged by the Technical Joint Cross Service Group's continued pattern of ignoring and even changing certified Navy data.

In respect for each Commissioner's time, I will keep my comments to two to three minutes but I feel it is my duty as an elected member of the U.S. House of Representatives to let them know of this abuse of process which has lead to a fatally flawed analysis by the TJCSG.
