

Dear Chairman Principi:

Last Monday, the Town Council of Vienna, Virginia voted unanimously to request that the Defense Base Closure and Realignment Commission (BRAC) schedule an additional regional hearing in Northern Virginia.

We applaud your courtesy last Friday in inviting Governor Warner, Senators Warner and Allen, and Representative Moran to listen to the military briefing on leased space proposals. Effective valuation of BRAC recommendations requires that state and local officials have access to the full range of data used by the Department of Defense (DOD) to create these recommendations plus the ability to offer the perspectives as to the accuracy of both the data and its interpretation.

These proposals by the Department of Defense concerning leased space have the potential of creating unanticipated consequences in terms of degrading military readiness and the Defense Department's ability to support our men and women in harm's way. In our view, these recommendations deviate from established BRAC criteria and merit close examination. We agree that military effectiveness can be improved by applying BRAC criteria consistently across the nation. We are concerned, however, that proposed disclosure could have grave consequences at a time when DOD can ill afford the potential loss of some of its most qualified defense scientists and technology experts. This would negatively impact on strategic military value.

In order to ensure objective evaluation of the data and assumption, including any disparate treatment of leased space, we would strongly urge a dedicated regional hearing in Northern Virginia, as suggested by Senator Warner and others. Northern Virginia, more so than any other region of the nation, has made its support of the needs of the military a priority. Transportation, land use, quality of life, economic development and all other community development decisions have been made with the needs of the federal government, and especially DOD, as a paramount consideration. In fact, since the 9/11 attacks, we have been collaborating with federal agencies, including DOD, to address security needs in a manner that is consistent with effective community development. We are not sure these initiatives have been adequately factored by DOD into the recommendations due to the wide and varied nature of leased space. Considering the substantial capital cost of military construction in Northern Virginia under DOD recommendations, leased space in secure business districts served by appropriate infrastructure more closely meets the needs of the military. We are prepared to offer important perspectives and would welcome the opportunity to inform the Commission of our analysis so that in the end the needs and objectives of all involved are met.

The 1993 Defense Base Closure and Realignment Commission established the precedent for holding single-subject regional hearings when it traveled to the City of Charleston, South Carolina (in May of 1993), for the express purpose of examining the impact of DOD's BRAC recommendations pertaining to that city and region. Therefore, the Town Council of Vienna, Virginia, respectfully calls upon the 2005 BRAC Commission to schedule a single subject hearing in Northern Virginia.


