Dear Senator Sununu,

This is in reply to your recent letter to Secretary Rumsfeld requesting details of the Cost of Base Realignment Actions (COBRA) model which will be used in the 2005 base realignment and closure (BRAC) process. While I appreciate your desire to receive this information while the Department's analysis is ongoing, the details of the BRAC decision making process must remain internal to the Department of Defense until the Secretary issues his closure and realignment recommendations in order to protect the integrity of the BRAC process. This is necessary to preserve the deliberative process and follow the statutory BRAC direction to treat all installations equally.

Revealing details of the decision making process through the release of such information as the elements of the COBRA model before the Secretary has made his closure and realignment recommendations could negatively affect the integrity of the BRAC process by opening it up to external and unequal influences; inhibit open and frank discussions necessary to produce quality decisions; and create public confusion from the premature disclosure of information that ultimately may not be the grounds for a recommendation to close or realign a military installation.




